- 2.2 I am providing consent for myself, additional adult(s) and/or minor(s) in the images.
- 2.3 I agree that the images may be used in combination with other images and may be modified, that I have no rights to inspect or approve the images or the use to which the images may be applied, and that I have no further right to additional consideration and will not make claims associated to the images, for any reason, to the Photographer, or any of the Project Partners.
