TERMS OF AGREEMENT

By participating in this Project, I understand and agree to the following terms:

1. Name of Project

- 1.1 I, the "Participant" voluntarily agrees to participate in a photos session, as well as complete a questionnaire and/or recorded interview for this Project, conducted by the "Partners".
- 1.2 I understand my interview may be recorded and/or transcribed. I also understand quotes from my questionnaire or interview may appear next to my name and/or images of me.

2. Photography Release

- 2.1 By signing this release, I grant to Kristy Wolfe Photography the right to license and use images from this Project. Digital high-resolution photographs taken of me and other participating individuals will be provided to me free of charge via an online gallery.
- 2.2 I am providing consent for myself, additional adult(s) and/ or minor(s) in the images.
- 2.3 I agree that the images may be used in combination with other images and may be modified, that I have no rights to inspect or approve the images or the use to which the images may be applied, and that I will not make claims associated to the images, for any reason, to the Photographer or any of the Project Partners.

3. Materials

- 3.2 Photographs of me and other participants;
- 3.3 Audio and/or visual recording of interviews;
